Stewardship of conservation areas and buildings on Trust property and enhancement of habitat on Trust properties and in other natural areas in the community. With the help of paid contractors and volunteers the Trust demolished an abandoned house and outbuildings on the new Trust property and continued to remove invasive species on all Trust properties. We planted native species and cared for plantings made in previous years. We restored the support structure of one wall of our barn at our Alder Creek Farm property and upgraded the electrical, ventilation, and watering system in our greenhouse on that property.

4b (Code: ) (Expenses \$ 10,611. including grants of \$ ) (Revenue \$ 2,717.)

Watershed and Nature Education. We provided watershed education and gardening education for 400 pre-school, elementary, and middle school students through individual class field trips to Alder Creek Farm and other nearby natural areas. We provided a birding workshop, a workday on local vegetation, and an amphibian workshop for adults. We co-sponsored a train excursion for all ages along the estuary with an educational interpretive presentation. We provided two presentations by regional authors in our environmental speakers series.

Coastal Food Ecology Center & Community Events. we sponsored a Community Garden program with 25 gardeners in the 2009 season and 28 gardeners in the 2010 season. Gardeners donate and deliver extra produce to the North County Food Bank, 1884 pounds in 2009. The Center hosted two workshops, pruning & seed starting. The Center also maintains a permaculture demonstration garden and a demonstration orchard. We are developing a Nehalem Teaching Trail on native plant and their uses. We presented two films on organic growing in celebration of National Pie Day. We held our annual free Harvest Festival for the community with music, cider pressing, games for the children, local produce and product vendors, and tours of the Community Garden at our Alder Creek Farm property.
